## 1.0 Connector Overview

The Avalara for Adobe Commerce connector provides rapid integration for Adobe Commerce implementations. The extension is open-sourced package that can easily integrate into any Adobe Commerce instance. This extension can be configured in the Adobe Commerce Administrator and contain all the elements necessary to perform a successful implementation of AvaTax **Tax Calculation, Address Validation, Tax Certificate, VAT** and **Cross-Border** services.

## 2.0 Configuration

To configure the Avalara for Adobe Commerce connector, navigate to **Admin > Stores > AvaTax Configuration > Sales Tax**.

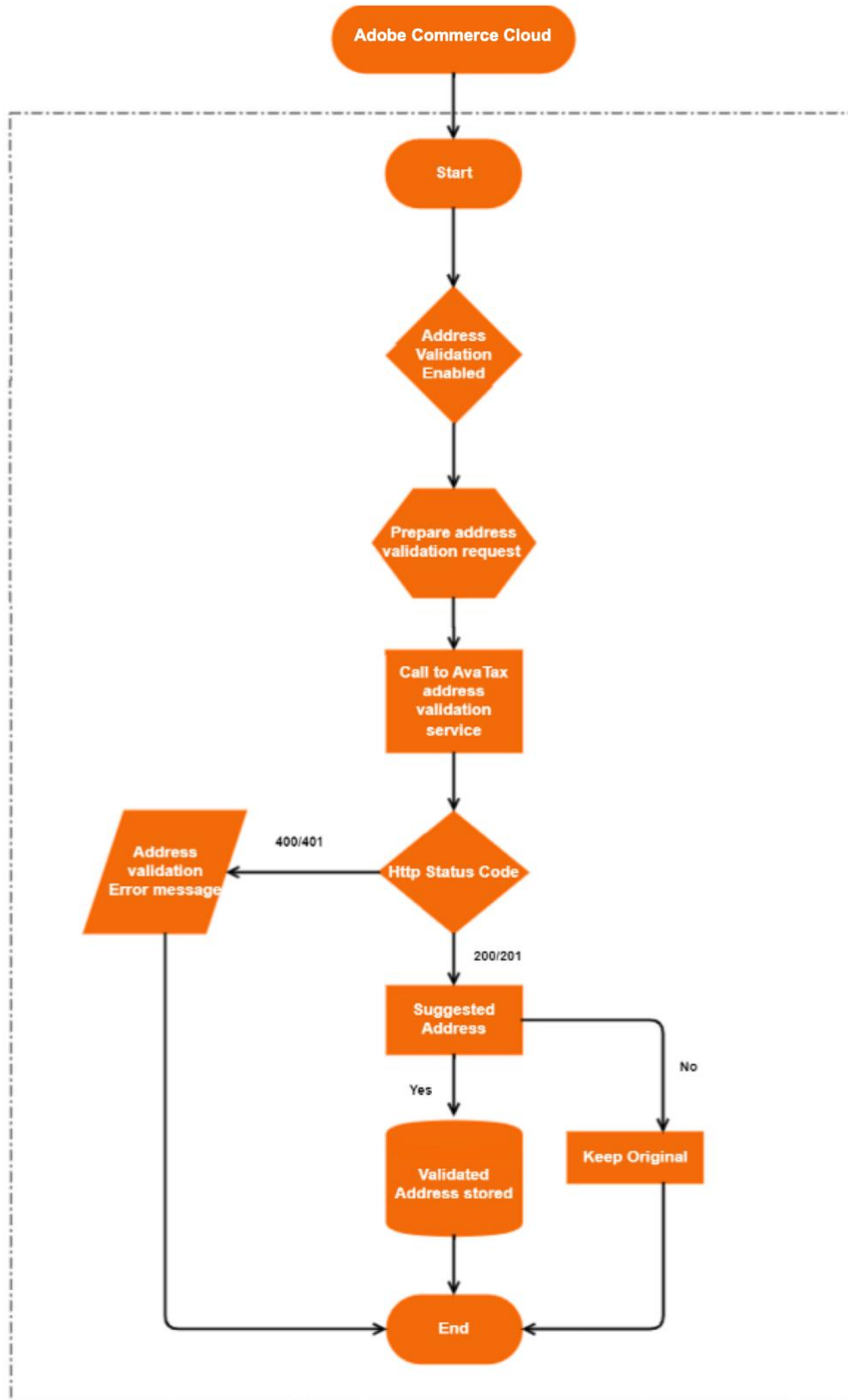
